CONSTITUTIONAL AMENDMENT QUESTIONS

Following are the questions submitted to the qualified voters of New Hampshire on November 7, 2006, together with the vote on the questions:

(Questions Proposed by the 2006 General Court)

Question No. 1. "Are you in favor of amending the first part of the constitution by inserting a new article 12-a to provide that private property can only be taken as follows:

[Art.] 12-a [Power to Take Property Limited.] No part of a person's property shall be taken by eminent domain and transferred, directly or indirectly, to another person if the taking is for the purpose of private development or other private use of the property."

Question No. 2. "Are you in favor of amending the second part of the Constitution by amending article 11 to read as follows:

[Art.] 11. [Small Towns; Representative by Districts.] When the population of any town or ward, according to the last federal census, is within a reasonable deviation from the ideal population for one or more representative seats the town or ward shall have its own district of one or more representative seats. The apportionment shall not deny any other town or ward membership in one non-flotarial representative district. When any town, ward, or unincorporated place has fewer than the number of inhabitants necessary to entitle it to one representative, the legislature shall form those towns, wards, or unincorporated places into representative districts which contain a sufficient number of inhabitants to entitle each district so formed to one or more representatives for the entire district. In forming the district, the boundaries of towns, wards, and unincorporated places shall be preserved and contiguous. The excess number of inhabitants of a district may be added to the excess number of inhabitants of other districts to form at-large or flotarial districts conforming to acceptable deviations. The legislature shall form the representative districts at the regular session following every decennial federal census."

The alteration and amendment in said Constitution covered by this question has been approved and adopted, and the Constitution is thus amended by the suffrages of more than two-thirds of the qualified voters present at the said meetings, and voting upon the said question.

RECOUNTS AFTER THE GENERAL ELECTION

Fifteen requests for recounts were received after the general election—all for the Office of State Representative. One recount resulted in a change of winners—Merrimack County District 9. The recount conducted in Hillsborough District 3 resulted in a tie. The tie was resolved by the General Court when they met on December 6, 2006—Organization Day.

The recounts requested in Carroll County District 3, Merrimack County District 2 and Merrimack County District 5 were called off before they were completed. There were no changes in any of the other recounts.

The recounts of Hillsborough County District 17 and Rockingham County District 4 were appealed to the Ballot Law Commission.

Below, in the first column are the figures as officially returned to the Secretary of State. The second column contains the recount figures, and the third column contains the figures after appeals to the Ballot Law Commission. Asterisks designate the person elected.
