### **RECOUNTS AFTER THE GENERAL ELECTION**

Fifteen requests for recounts were received after the general election—all for the Office of State Representative. One recount resulted in a change of winners—Merrimack County District 9. The recount conducted in Hillsborough District 3 resulted in a tie. The tie was resolved by the General Court when they met on December 6, 2006—Organization Day.

The recounts requested in Carroll County District 3, Merrimack County District 2 and Merrimack County District 5 were called off before they were completed. There were no changes in any of the other recounts.

The recounts of Hillsborough County District 17 and Rockingham County District 4 were appealed to the Ballot Law Commission.

Below, in the first column are the figures as officially returned to the Secretary of State. The second column contains the recount figures, and the third column contains the figures after appeals to the Ballot Law Commission. Asterisks designate the person elected.
