Gardner, Acting Governor of the State of New Hampshire, in obedience to the request of the Constitutional Convention holden at Concord, the second Wednesday of May, 1974, the 1977 General Court, and the 1981 General Court, do hereby proclaim to the people of this state that the Constitution of New Hampshire is amended as provided for in questions 1, 2, and 3 which were submitted by said Constitutional Convention, the 1977 General Court, and the 1981 General Court, to the qualified voters of the State at the meetings held in the several towns, city wards, and places in this State, on the Tuesday next following the first Monday in November, 1982.

The alteration and amendments in said Constitution covered by these questions have been approved and adopted, and the Constitution is thus amended by the suffrages of more than two-thirds of the qualified voters present at the said meetings, and voting upon said questions.
