RECOUNTS AFTER THE GENERAL ELECTION

Ten requests for recounts were received after the General Election. Seven of these were Representative races held on November 17, 18 and 24. A recount for Sullivan County Register of Probate was held on November 19, and a recount for Strafford County Commissioners was held on November 20-21. A recount requested for State Senate District No. 8 was called off by Peter Burling before it was begun.

There were no changes in any of the recounts except Strafford County Commissioners. Paul H. Proulx was declared the winner after the election, but George A. Young, r, won the recount.

Below, in the first column are the figures as officially returned to the Secretary of State following the election. The second column contains the recount figures. The names of the persons elected are designated by asterisks.
